

# PRUSHKA ELECTRONIC NET REFUND

If you wish Prushka to electronically send you the net amount of money collected for you, then the process is:

- Prushka will **electronically pay** into your nominated account the **net** of all payments collected.
- Tax invoice will be sent by **email**, detailing charges (deducted from payments received from debtors).
- If your account is in **debit balance**, pay off the emailed Tax invoice within **21 days settlement period**.

- You receive your money as **cleared funds** that you can draw on immediately
- Your refund will be processed within the **first 5 working days of each month**
- Save on handling costs and bank fees
- No chance of lost cheques
